APPLICATION FOR STUDENT DEPARTURE FROM SCHOOL PREMISES

Please encourage your student to respect the rights of neighboring property owners and refrain from littering. If a student is found to be on private property, loitering or littering at these times, the student will be subject to revocation of the off-campus lunch privilege (OCLP) photo identification (ID) badge, all privileges associated with the OCLP photo ID badge, and/or additional school restrictions. This is an effort to protect the privileges of the many well-behaved students from the misconduct of a minority of students.

- 1. All students in grade 12 and eligible (3.2 quarterly GPA) 11th grade students may leave the school building/campus during their scheduled lunch period with both parental and BASH school administration permission. Students must show and scan required school issued OCLP photo ID badge when departing the building. Students electing to leave the school building/campus must do so within the first (5) five minutes of the scheduled lunch period and may not return until (5) five minutes before the end of the scheduled lunch period.
- 2. A student who, upon arrival at school in the morning by bus or private transportation, leaves the school premises prior to the start of homeroom is in violation of school regulations.
- 3. Students are not permitted to leave the school building/campus at any time during the school day without joint parent and BASH administration approval.
- 4. Any student trespassing on private property within a three-block perimeter of the BASH property between the hours of 7:00 a.m. and 3:30 p.m. may be subject to a fine for defiant trespass, without additional prior notice or civil complaint by the property owner.
- 5. Students reported loitering or littering off BASH property between the hours of 7:00 a.m. and 3:30 p.m. will be subject to borough ordinances regarding such behavior, as well as being subject to BASH disciplinary measures, including the loss of the OCLP.
- 6. No student is permitted to drive, ride, or sit in a car during the school hours, including the OCLP period, even though the student is holding a valid OCLP photo ID badge.
- 7. When a student with an OCLP photo ID badge leaves the building/campus, BASH and the school district's responsibility for the student's welfare is waived until the student returns to the building/campus.
- 8. Permission to leave BASH during the student's scheduled lunch period time will be revoked by BASH administration for the reported violation of any of the above conditions. Additional disciplinary action may also be taken in accordance with BASH's disciplinary regulations.
